Why the VPFF Endorsed Abigail Spanberger for Governor of Virginia:

Examples of legislative support:

- She led the repeal of the WEP/GPO program which put thousands of dollars back into the hands of retired firefighters across the country
- She was the chief co-patron of the Michael Lecik Military Firefighters Protection Act (HR.4306) which
 provides veteran firefighters with fair compensation, healthcare and retirement benefits they've
 earned
- She was a co-sponsor and voted in favor of numerous bills, including:
 - 911 SAVES Act: reclassifying dispatchers as first responders
 - Honoring Our Fallen Heroes Act: to expand PSOB benefits to firefighters who die from cancer
 - Firefighter Cancer Registry Reauthorization Act
 - Consumer Safety Standards for Lithium Ion Batteries Act
 - Federal Firefighter Pay Equity Act
 - Firefighters and EMS Employee Employer Cooperation Act
 - PFAS Airports Act
 - Federal Firefighters Fairness Act
- She supported the reauthorization of the SAFER and AFG grant programs
- She supported legislation safeguarding federal firefighter pay during government shutdowns

VPFF Candidate Questionnaire:

- She answered favorably to **all** of the questions posed on the candidate questionnaire. The questionnaire included the following topics:
 - Collective bargaining
 - Cancer screening for firefighters
 - · Workers' compensation
 - LODA time period for filing
 - Dedicated fire service funding
 - Fire service grant funding
 - Enhanced retirement benefits for 911 dispatchers

The *Virginia Professional Fire Fighters* was the first public safety organization to endorse Abigail Spanberger. Since then, the *Virginia Police Benevolent Association*, the largest police organization in Virginia, has also endorsed her campaign demonstrating confidence in her ability to support the efforts of all public safety workers across the Commonwealth.
